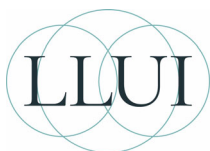

1 Overview

This document provides an overview of tuition and administrative fees for studies at the Lake Lucerne Institute (LLUI).

All fees are charged in Swiss Francs (CHF).

Please note: The legally binding version of the fee regulations is the German-language document ([*Gebührenordnung LLUI*](#)). This English version is provided for informational purposes to support international students.

2 Registration Fee (one-time)

Registration Fee: CHF 100

A one-time registration fee of CHF 100.- is charged when submitting an application for admission to a Master's program at LLUI.

This fee applies only if you have not previously been enrolled in a Master's program at LLUI.

Tuition Fees – Master's Programs (per semester*)

CHF 850.- per semester

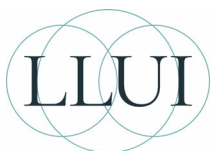
This tuition fee applies to:

- Swiss nationals
- Nationals of EU/EEA countries
- Non-EU/EEA nationals with a permanent or long-term residence permit in Switzerland
- Students who completed their secondary education (Matura) in Switzerland or an EU/EEA country

CHF 1'250.- per semester

This tuition fee applies to:

- Students from non-EU/EEA countries who do not meet the criteria listed above.



2.1 Leave of Absence

A *leave of absence* refers to an officially approved temporary interruption of studies for one semester (e.g. due to personal, medical, or professional reasons).

Students who are granted an approved leave of absence are required to pay a reduced administrative fee of **CHF 100.- per semester** during the leave period.

Applications for a leave of absence must be submitted in advance and approved by LLUI. Requests should be submitted via education@llui.org.

2.2 Guest Students (Exchange and Mobility Students)

Guest students who attend LLUI as part of mobility programs and/or collaboration agreements are exempt from tuition fees. Guest students may take examinations and receive certificates for the credits obtained; however, they are not awarded a degree.

2.3 Guest Auditors (Gasthörer/in)

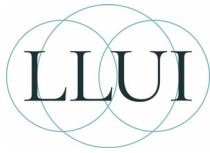
Guest auditors attend selected course units without participating in examinations or other assessment formats. Fees are charged based on the number of course units attended. The fee per module is determined by the program management.

2.4 Examination Fees

Fees for examinations are included in the tuition fees. Fees for repeat examinations are determined uniformly by the responsible program management.

2.5 Continuing Education Programs

The Rectorate is authorized to set tuition fees for continuing education degree programs and programs within the usual market range. The applicable fees are published on the LLUI website.



2.6 Special Services and Administrative Fees

For special services provided by LLUI—particularly administrative, usage, and decision-related fees—the Rector (or Rectorate) determines the applicable fees.

2.7 Important Note

This document is an English translation of the official German-language Fee Schedule (*Gebührenordnung LLUI*) and is provided for reference only. In the event of any discrepancies between this English version and the German-language document, the German version (*Gebührenordnung LLUI*, effective September 1, 2024) shall be legally binding and take precedence.
